Customer Satisfaction Survey 2026/27

About the Survey

In May and June 2026, many of you took part in an important survey. A sample of customers were invited to take part in a survey by completing either a telephone or online questionnaire.

The survey was carried out by an independent market research company, Acuity Research and Practice. It focused on how happy you are with the way Coastline Housing maintains your home and delivers key services. The survey also collected the Tenant Satisfaction Measures (TSMs) as required by the Regulator of Social Housing.

The findings will provide a view of the main drivers behind satisfaction levels and the issues customers are most concerned about, informing Coastline Housing's future strategic and operational planning.

This report contains key survey results regarding customers' opinions about their homes and the services received. Please note that the results are shown as percentages and are rounded up or down from multiple decimal places to the nearest whole number. Therefore, the percentages may, in some cases, differ by 1% when added together.

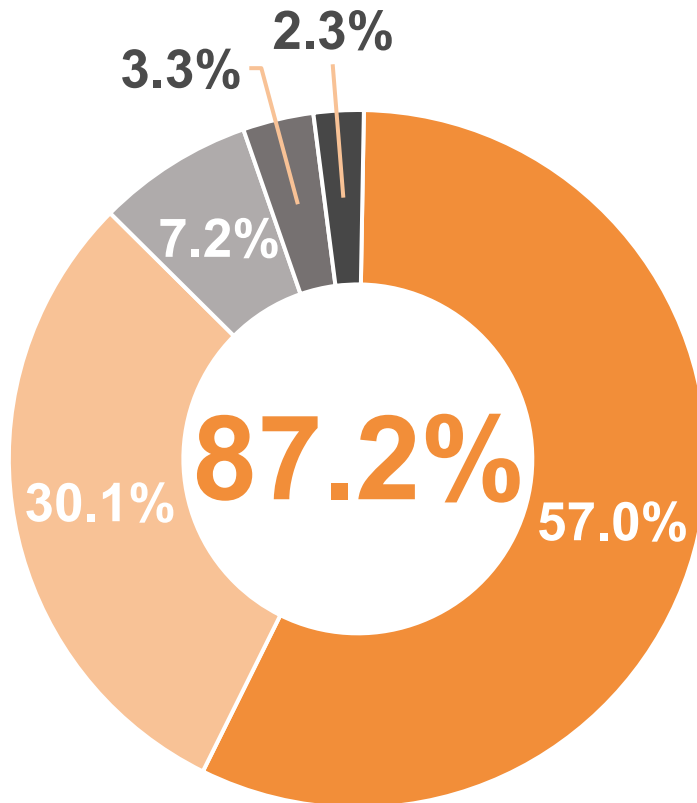

Overall Satisfaction



Almost nine out of ten customers are satisfied with the overall service provided by Coastline Housing (**87.2%**).

The Home and Communal Areas



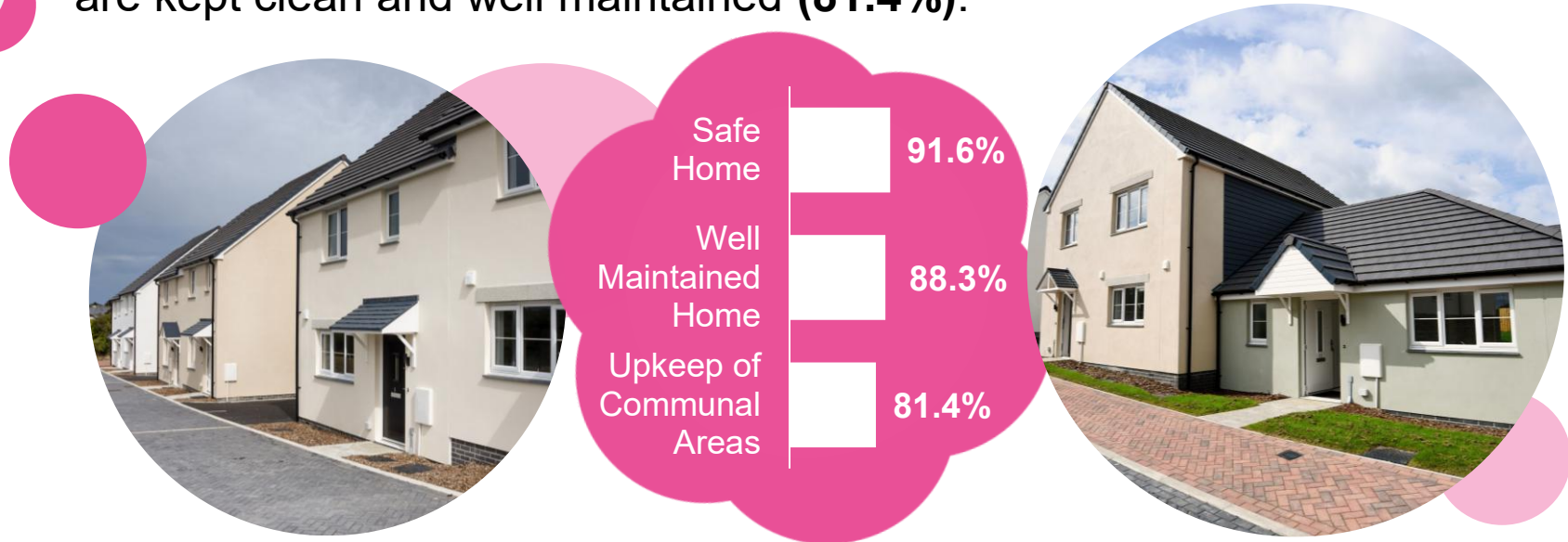
Over nine out of ten customers are satisfied that Coastline Housing provides them with a home that is safe **(91.6%)**.



Slightly fewer customers are satisfied that they are provided with a home that is well maintained **(88.3%)**.



Eight out of ten customers with communal areas are satisfied that these areas are kept clean and well maintained **(81.4%)**.



The Repairs Service



Seven out of ten customers said they had a repair carried out to their home in the last 12 months **(70.8%)**.



Nine out of ten of these customers are satisfied with the overall repairs service over the last 12 months **(89.5%)**.



Slightly fewer customers are satisfied with the time taken to complete their most recent repair **(87.5%)**.

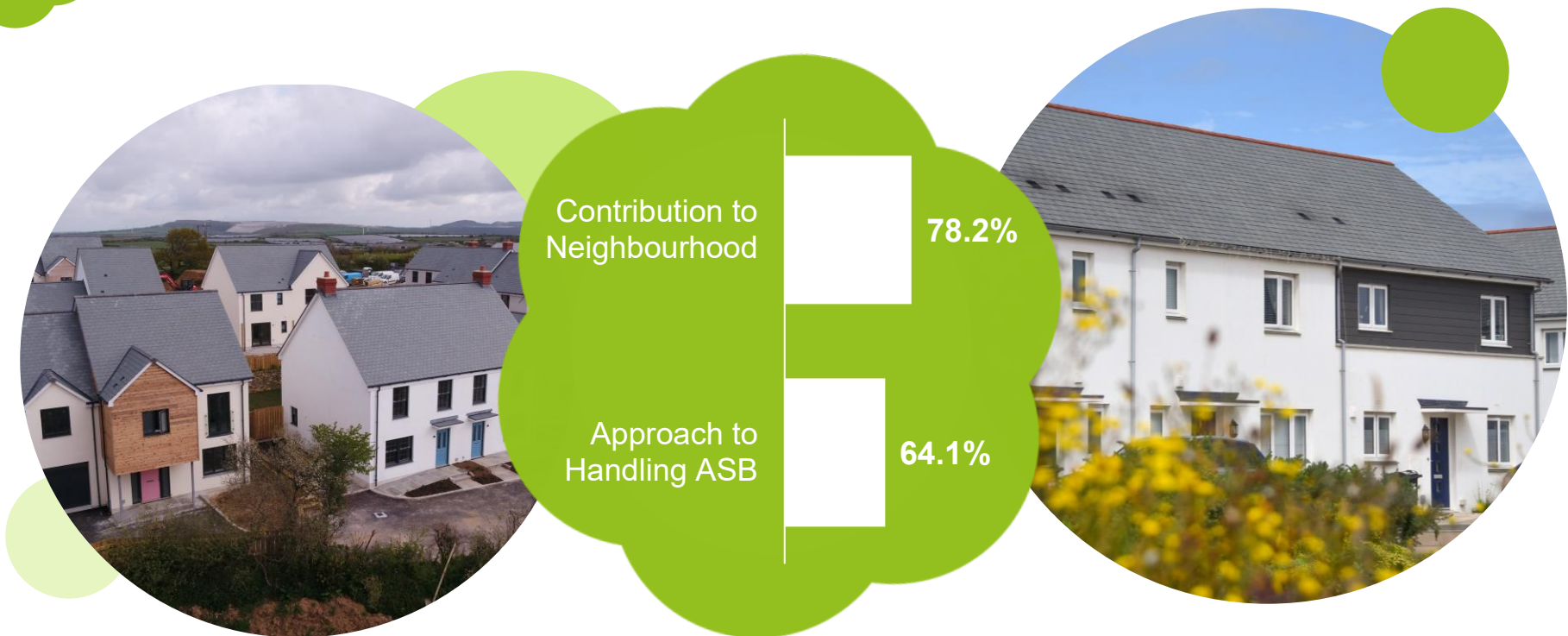
Neighbourhood Management



Around eight out of ten customers are satisfied that Coastline Housing makes a positive contribution to their neighbourhood (**78.2%**).



Fewer customers are satisfied with Coastline Housing's approach to handling anti-social behaviour (**64.1%**).



Respectful and Helpful Engagement



Three-quarters of customers are satisfied that Coastline Housing listens to their views and acts upon them **(74.5%)**.



Over eight out of ten customers are satisfied that they are kept informed about things that matter to them **(83.9%)**.



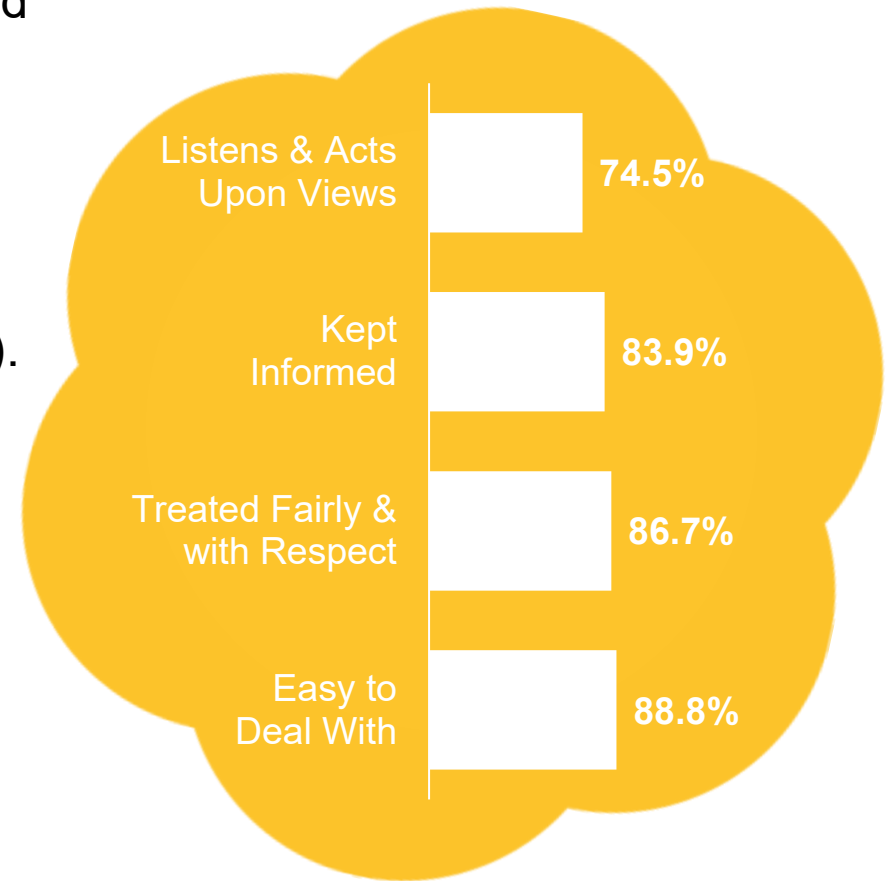
Six out of seven customers agree that they are treated fairly and with respect by Coastline Housing **(86.7%)**.



Nine out of ten customers are satisfied that Coastline Housing is easy to deal with **(88.8%)**.



When asked to comment on the customer service and communications from Coastline Housing, many customers are positive about the staff being polite, friendly and helpful, and problems being resolved quickly.



Handling of Complaints



One out of six customers said they had made a complaint to Coastline Housing in the last 12 months **(16.3%)**.



Around half of these customers are satisfied with Coastline Housing's approach to complaints handling **(47.5%)**.



Recommending Coastline Housing



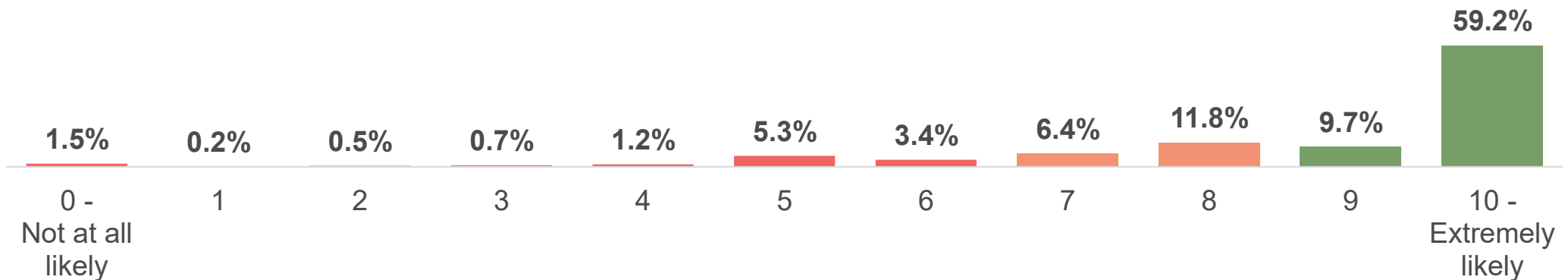
Customers were also asked how likely they would be to recommend Coastline Housing to other people. This is a 0-10 point rating. Those who would recommend the association score 9 or 10, those who are unsure score 7 or 8, and those who would not recommend them to others score 6 or below.



Seven out of ten customers are very loyal and happy to recommend Coastline Housing to other people (**68.9%**). However, **18.2%** of customers are unsure, and **12.9%** would not recommend them.



The 'Net Promoter Score' for Coastline Housing (the percentage of those who would recommend Coastline Housing minus the percentage of those who would not) is **+56**.

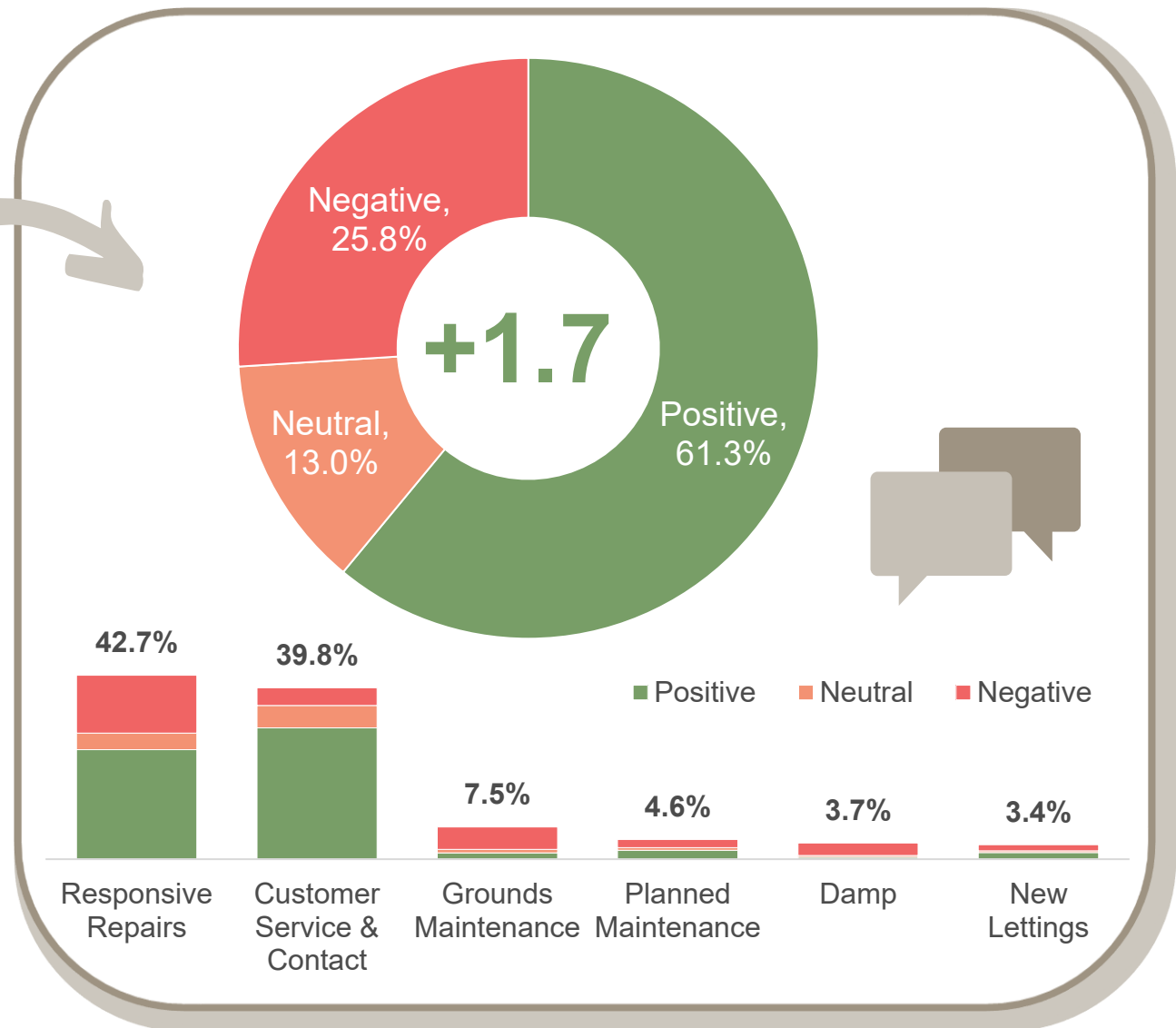


Customers' Comments

Customers were asked to describe their specific experiences that have shaped their view of the overall service provided by Coastline Housing, and 829 comments were received.

Six out of ten of these comments have positive sentiment (**61.3%**), **13.0%** neutral, and **25.8%** negative sentiment. This gives a positive overall sentiment score of **+1.7** (on a scale from -5 to +5).

The most commonly mentioned categories by customers are responsive repairs (**42.7%**) and customer service and contact (**39.8%**), followed by grounds maintenance (**7.5%**).
